### 7.1 Safeguarding your privacy online

PT Solutions Limited is committed to safeguarding your privacy online. ### 7.2 What personally identifiable information does PT Solutions Ltd collect from me?

PT Solutions Limited collects information in several ways from different parts of our web site.

Some personal information is gathered when you register on the Website. During registration, PT Solutions Limited asks for your name, email address, telephone number, account number and company name. Once you register you are no longer anonymous to PT Solutions Limited.

In addition to registration we may ask you for personal information at other times, for example when you report a problem with our Website or services. If you contact PT Solutions Limited we may keep a record of that correspondence.

When you order, PT Solutions Limited will need to know your name, e-mail address, delivery address, credit or debit card number and the card's expiry date. This allows us to process and fulfil your orders and to notify you of the status of your order.

PT Solutions Limited may use cookies as a means of offering and providing customisable and personalised services. However, your browser has settings that will allow you to accept all cookies, be informed as cookies arrive or reject all cookies. The downside of rejecting all cookies is that we are then unable to match the site content we offer you to what we know about your preferences from your previous visits.

PT Solutions Limited may also collect IP addresses for system administration, for independent audit and to report aggregate information to advertisers. By this we can see how our sites are being used, for example, what services and facilities are popular, and how long users spend on particular pages. This is data about our users' browsing actions and patterns and it does not identify anyone individually.

When you telephone PT Solutions Limited, or someone who is dealing with calls on our behalf, we may record the conversation to ensure the security of any transaction discussed, to help us to review our quality of service and to assist in the training and development of the employees who take such calls.

## 7.3 How does PT Solutions Limited use my information?

PT Solutions Limited primary goal in collecting personal information concerning subscribers is to provide them with a customised experience of our site. By knowing a little about you, PT Solutions Limited is able to deliver more relevant services and content to you.

PT Solutions Limited and any of its associated companies are prohibited by virtue of the Data Protection Act 1998 from disclosing any of your personally identifiable information except when we have your permission or under special circumstances, such as when we believe in good faith that the law requires it or under the circumstances described below. The following describes some of the ways that your information may be disclosed:

PT Solutions Limited may employ other companies and individuals to perform delivery functions on its behalf or to process credit card payments or to provide customer services. Such companies and individuals will have access to personal information needed to perform these functions, but may not use it for any other purposes and are required to process the data in accordance with the UK's Data Protection legislation.
